## **LIST OF MOST IMPORTANT EVENTS OF PARTICULAR IMPORTANCE FOR CITIZENS IN THE REPUBLIC OF SERBIA**

### **Article 1**

The list of most important events of particular importance for citizens in the Republic of Serbia determines the events of importance for the public of the Republic of Serbia or the member states of the European Union.

### **Article 2**

The list of most important events of particular importance for citizens in the Republic of Serbia consists of the following events:

1. Summer and Winter Olympic and Paralympic Games, European and World Para Championships, Special Olympics
2. Semi-final and final matches of the FIFA Football World Cup and UEFA European Football Championship (seniors), matches of those championships in which the Serbian national team participates and qualification matches for those championships in which the Serbian national team participates
3. UEFA Champions League, UEFA Europe League and UEFA Conference League matches in which a Serbian club participates, except for qualification matches for those competitions
4. Semi-final and final matches of the FIBA Basketball World Cup and European Basketball Championship (seniors) and matches of those championships in which the Serbian national team participates
5. Semi-final and final matches of the World and European Handball Championships and matches of those championships in which the Serbian national team participates
6. Semi-final and final matches of the World and European Volleyball Championships and matches of those championships in which the Serbian national team participates
7. Semi-final and final matches of the FIVB Volleyball World League, if the Serbian national team is participating in them
8. Semi-final and final matches of the World and European Water Polo Championships and matches of those championships in which the Serbian national team participates

9. Super-final match of the FINA Water Polo World League, if the Serbian national team is participating
10. Semi-final and final matches of the Davis Cup and the Fed Cup, if the Serbian national team is participating in them
11. World and European Athletics Championships, in case of disciplines in which Serbian contestants are participating
12. World Athletics Indoor Championships
13. EXIT music festival
14. Guča music festival
15. BITEF festival
16. FEST International Film Festival
17. Küstendorf International Film and Music Festival

On the day of adoption of this decision, the list of most important events of particular importance for citizens in the Republic of Serbia of 16 March 2021 shall cease to be valid.
