Dear Sir/Madam,

We hereby submit the translated version of the complaint we have received, together with the accompanying attachments:

"Children are being used in the promotion of crossdressing / transvestites. Channel Pekaboo, show Doopie. 15.11.2025. at 06: 29 / 12: 17 / 18:26.

I understand that freedom of speech exists, that such shows exist and I cannot forbid them, but I think every boundary is crossed when it comes to a children's channel and brainwashing children of that age.

I am asking you to react so that this show is removed and to get a statement from representatives of SBB/ Pekaboo as to whether the editor did his job, and how it is possible that such shows are aired on a children's channel, because I imagine that this cannot be shown on the other 18 channels they have.

If they cannot stop airing this show, let them remove a specific show / cartoon, or in the final case the channel, because we are talking about CHILDREN'S channels which MUST be maximally filtered.

Thank you in advance and I am asking for a reply. Images attached."

Hvala unapred i molim za odgovor.

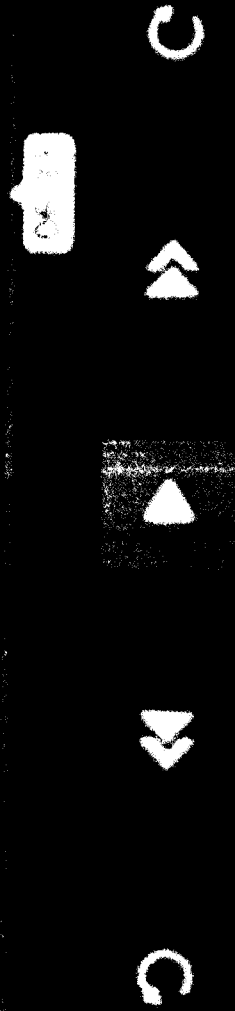
