### **Report of the Monitoring and Analysis Service**

Ex officio **procedure**, upon a complaint **XXXXXXXXXX** from the organisation

**Short description:** A discussion with Vjerica Radeta about student protests.

---

**Report:** The complaint relates to the content of the Info jutro show belonging to the news and current affairs genre, current affairs subgenre; a discussion with Vjerica Radeta, presented as the Vice President of the SNS, as the only guest in the relevant segment of the programme. The topic of the discussion is broadly related to public events that are part of the political protests initiated due to the fall of the canopy at the railway station in Novi Sad.

#### Transcript

**Vjerica Radeta:** I think that Zlatibor Loncar should, if possible in any way, organise a psychiatric examination of all these sick people as part of these various training sessions conducted successfully across Serbia. Because those of sound mind cannot do what they are doing, they really cannot. No matter how much money they get, but you know how much money they need to... how much money this Mila Pajić and this Kesić got to make...

**The host:** Have you seen that broadcast?

**Vjerica Radeta:** It is such a scandal. They turned girls, children, into witches. They put black wigs on them. Red lipstick, black crayon around their eyes. It is really creepy.

These children were brought there to applaud to Mila Pajić with that frazzled look of hers and then she teaches them what they can do until they reach the point of becoming students. And then, as students, what they can then change. She only forgot to tell them that students need to study, that students need to graduate from their colleges in which they enrolled, and, that obvious mercenary somehow forgets to say what year she is. How many exams she has passed. We have not forgotten her from the days of Ribnikar, before that concerning the election results, with her bulging eyes in front of the Assembly, saying she will not tolerate it, she cannot do it, as if the whole world would stop if Mila cannot or will not endure something.

The presentation of extremely critical attitudes ("psychiatric patients", "mercenaries"...) about Mila Pajić and Zoran Kesić, in connection with their public activities clearly implies the need to include in the discussion the arguments of the opposite party and the obligation of TV Informer to provide an opportunity to participate in the discussion in an equal manner (Article 8, Paragraph 1 of the **Rulebook on the Protection of Human Rights in the Area of Media Service Provision**), which was not done.

Transcript:

**Vjerica Radeta:** The money for financing these so-called student protests, but in reality the blockade, is distributed by Aida Čorović. Imagine letting your goat guard your cabbage. Aida Čorović is a thief, a criminal, not only because she works against Serbia, not only because she is bothered by the mural of Ratko Mladić so she defaces it in Belgrade, but because in Novi Pazar she, together with her either husband or common-law partner, whatever he is to her, with this man she plundered the Public Water Supply Company. They took a lot of money, criminal proceedings were conducted, they were saved by Rasim Ljajić. Because his party was in power at that time.

(...)

It is not Aida Čorović, no one has a problem with her because they suddenly just decided that they have a problem with Aida Čorović, it is her who has a problem with Serbia. She has the right to say that institutions do not work in Serbia. If they had worked, she would be in jail today, as a thief who plundered the Public Water Supply Company in Novi Pazar. And now she is the one who is distributing money to these students.

The fact that in a news and current affairs programme, without any reservation, unverified and completely unsubstantiated information that "Aida Čorović is distributing money" was presented, the named person was, unrelated to the topic of the discussion, labelled as a thief and a criminal, and in order to discredit her publicly, private information was also included ("husband or common-law partner, whatever he is to her"). By not enabling other interested parties to participate in an equal manner related to the broadcasting of information where they have the right to respond, once again, the actions were contrary to Article 8, Paragraph 1 of the **Rulebook** (Hear the Other Side Rule).

As a whole, the described actions of TV Informer did not allow for free, truthful, objective, full and timely information, and in particular not for the news and current affairs programmes to provide a truthful and objective representation of facts and events and to encourage the free formation of opinion, which is stipulated by Article 4, Paragraph 1 of the **Rulebook** (General obligation), nor for the veracity and completeness of ideas and opinions it broadcasts, particularly in news and current affairs programmes, with due care corresponding to circumstances and in accordance with the rules of the journalistic profession (Article 5, Paragraph 1 of the **Rulebook** – Truthfulness, completeness and diversity of information).

**Conclusion:** Proposal to initiate an examination procedure, due to content inconsistent with the **Rulebook on the Protection of Human Rights in the Area of Media Service Provision:**

- Article 4, Paragraph 1;
- Article 5, Paragraph 1;
- Article 8, Paragraph 1;

in connection with Article 61, Paragraph 1 of the **Law on Electronic Media**.
